SAFE DRINKING WATER AND SANITARY CONDITION CERTIFICATE

Name of the School: - Delhi Public School, Fulbari

Curriculum: - CBSE

Location: - Chhobavita, Canal Road Fulbari P.O. Bhaktinagar, Jalpaiguri-734015

Descriptions of the School: - There are all total 49 rooms including 36 Classrooms, 9 Labs, 2 Wellness room/Clinic, 1 Staff room and 1 Library. There are 24 Washrooms with separate provisions for male and female. All the rooms and also all the washrooms are well maintained w.r.t. the sanitary conditions. There is one mini canteen within the school building for the students which is not for commercial purpose and well maintained w.r.t. the sanitary conditions. There is also one Cafeteria outside the building within the campus used for commercial purpose which is running by a third party agency. All the norms w.r.t. Food Safety has been informed to the agency.

Descriptions of Surrounding: - The areas surrounding the school building are well maintained w.r.t. the sanitary conditions. There is drain along the boundary wall which is connected to a high drain outside. The garbage generated is regularly cleared and dumped in a separate area within the campus far away from the school building. Both the drain and garbage are treated regularly.

Source of water: - The source of water is through submersible pump through which the water lifted to the overhead tank and after purifications through RO filter and chlorination supply to the building for difference purpose.

Cleanliness Activities: - The School premises and the building are being cleaned regularly and maintained through third party agency. Occasionally, the students are being involved in cleanliness activities as a part of their social educations.

Social Activities: - The School undergoes different social activities for examples - Think Green Plantation Programme on February 2019, Mahananda Cleanliness on February 2019, Conservation of Water on June 2019 etc.

Therefore, this is to certify that an inspection was done by the team headed by Dy. CMOH-II, Jalpaiguri from the Department of Health and Family Welfare on 27.02.2020 and found that the Delhi Public School, Fulbari, Chhobavita, Canal Road Fulbari P.O. Bhaktinagar, Jalpaiguri 734015 has safe drinking facilities for the students and members of staff of the institution and is maintaining the hygienic sanitary condition in the school building and the campus as per the norms prescribed by the central/state/U.T. Govt.
