Delhi School Education Act & Rules, 1973.

Sir,

With reference to your letter dated 21.12.1981 on the subject noted above, I am directed to convey the permission of Director of Education, Delhi to your society to start a school in Mauj Pur from classes I to VIII, subject to the following terms and conditions.

1. That the provisions of the DSEA, 1973 and Rules framed thereunder shall be observed by the society.
2. That the Management of the school will fulfill all the conditions laid down under rule 50 and provide all the facilities given in rule 51 of DSEA 1973 to the institution.
3. That the management of the school will get the scheme of management approved from the Department immediately.
4. That only qualified and ~~xx~~ trained teachers shall be appointed and prescribed Govt. scale alongwith all allowances may be paid to the teaching and non teaching staff through corss cheques.
5. That the school will not run for the profit of any individual association or group of persons.
6. That the management of the school will not ask for grant-in-aid from the Department.
7. That in case at any time the management of the school is unable to run the school movable and unmoveable, property will be transferred in the name of Director of Education.
8. That the management of the school will apply for grant-in-aid of recogniton of the school under the DSEA and Rules 1973 separatly in the next academic session i.e. 1983-84.
9. That the school shall be started after construction of proper rooms for classes I to 8 by getting the existing building altered to have 8 rooms of size 18x20/20x20 as proposed by the management of the society.
10. That the management of the society will also ensure the availability of funds to the tune of Rs.10.00 lakhs as assured by the secretary of the society.
