| 1 | The total number of sections of Bal Vatika shall be restricted to 03 (one sections each in Bal Vatika I, II & III respectively) and total number of sections of the school from class I to X shall be restricted to 14. The optimum number of the students shall be restricted to 40 in each section. Further, increase of sections shall be subject to specific approval of the Board on the basis of the request of the school as per affiliation bye law and availability of class rooms of greater than 500 sq ft dimension. |
| 2 | The school has filled the incorrect land details in the application i.e. 10679 sq mtrs, whereas as per renewed land certificate school is running on 6014.25 sq mtrs of land. Thus, the school is directed to apply on SARAS Portal for correction of land area from 10679 sq mtrs to 6014.25 sq mtrs and submit an undertaking in this regard on its letterhead duly signed by principal and manager of the school within 03 months and submit the compliance. |
| 3 | The school is directed to submit the copy of renewed permanent recognition certificate and society registration certificate / trust deed within 03 months in the compliance. |
| 4 | The certificate of water and sanitation does not have the date of expiry, which cannot be in perpetuity. Thus, the school is required to obtain Safe Drinking Water and Sanitary Condition Certificate as per format i.e. Annexure-C of SARAS Manual issued by an officer not below the rank of an Assistant Engineer of the Government Public Health Department(PHED), within 03 months and submit the compliance. |
| 5 | In the compliance, school functionaries have stated that the composite science lab is equipped. However, school has separate labs for physics, chemistry and biology. As the school is affiliation upto secondary level only. Hence, it is required to set-up a composite science lab including the workstation for all three science subjects (physics, chemistry and biology) as per Board's SoP within 03 month and submit the compliance. |
| 6 | The internal view of the CwSN toilets have not been covered in the videography, hence facilities available in the same cannot be ascertained. Thus, the school is required construct the CwSN toilets separately for boys and girls on each floor with sufficient space for easy movement of the wheelchair as well as handrail on both side |

| | of toilet seat (fixed and movable) and proper permanent signage (on the cubicle indicating the floor number) as per norms of RPwD Act and board's guidelines within 03 months and submit videography link covering the same in the compliance. |
| 7 | The school shall conduct training of its teachers with CoE Noida and submit the compliance within 03 months. |

Compliance of the above mentioned points shall be submitted within 03 months on the SARAS Portal. Failure to comply within the prescribed time shall invite financial penalty @ 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.

The above sanction is subject to fulfillment of following conditions:-

1. The approval is based upon the documents /data/information uploaded by the school online. The school will be responsible for its genuineness. In case of any discrepancies, necessary action will be initiated against the school as per Affiliation Bye -Laws-2018.
2. The school will follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
3. The School is required to apply on online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
4. The school should go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy there of for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
5. The school is required to renew mandatory certificates from time to time.
6. The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
7. The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
8. The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

“The school shall possess valid fire safety certificate and Building safety certificate during functioning of the school which shall be renewed from time to time as per norms”.

If the compliance is not submitted with in the stipulated 3 months , the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
